## Set up and receiving day is Saturday/Sunday April 9<sup>th</sup> and 10<sup>th</sup> 2016

both days from **10am until 1pm**.

The opening night will be on Monday 11<sup>th</sup> April from 6pm. Closing day is Saturday 30<sup>th</sup> April 2016. All unsold work should be **collected on the closing day before 12.30pm** – or please make arrangements to have your work collected as we have no storage space at the library.

## Conditions and regulations for entry:

1. This exhibition is an **open exhibition** meaning that all mediums (watercolour/oil/pastel/acrylic) will be accepted – class work will be accepted if permission has been given and conditions of permission are met - entrants can deliver up to **4 pieces** – two will be hung immediately and 2 kept in reserve. This is a “cash and carry” exhibition with purchasers able to take the work once the work is paid for. Reserve paintings will be hung as room dictates.
2. The entry fee for this exhibition will be a flat **\$15** for up to 4 paintings. This may be paid at the time of registering, online to the account listed at the end of the form or by cheque made out to the Auckland Watercolour Society and posted to the secretary (address below).
3. An amount of **20% deducted** from sales, which will **go to a charity** of the Auckland Watercolour Society's choice. When costing their work, artists should take this into account.
4. All work must be **ready to hang - i.e d-rings/cord/framed securely and neatly sealed** on the back with adequate tape. **Swing tags** with artist's name/address/phone number/title of work/cost must be attached **with cord long enough to be hung over the front** of the painting when hung (If you need advice on framing your work please phone or email the secretary)
5. **All work to be for sale**. This is a cash and carry exhibition. Works are sold framed as they are and may be removed immediately by the purchaser. There is no guarantee that correct contact details of the purchaser will be obtained. We recommend to name your contact details at least on the back of the frame. For members of the Auckland Watercolour Society we invite and encourage you to list your membership with your contact details.
6. The Auckland Watercolour Society will **not be responsible** for any damage or theft which may occur to art work whilst the show is on though all reasonable care will be taken. The works are **not insured**. Entrants should arrange for their own insurance if deemed necessary.

7. Artists are requested **not to remove their work** from the display screens until the exhibition is finished – in an emergency please ask the committee if works can be removed.
